ENROLLMENT STIPULATIONS AND REQUIREMENTS

- 1) All tuition fees and installments can be paid in advance or by the first of the month with a personal check or money order. A.C.T. reserves the right to request payment in cash if the payment is made after the "due date." Select credit cards can be used for payments. There will be a 2.8% processing fee for every credit card transaction.
- 2) Failure to comply with the payment schedule, contractual agreements or program regulations forfeits placement in any or all programs.
- 3) Annual users are responsible for full payment of annual tuition regardless of use and must sign a contract.
- 4) No refunds, credits, make-up, substitutions, transfers or change of days is permitted or granted.
- 5) Additional fees may apply:
 - a) A fee of \$30.00 will be charged for returned checks.
 - b) A fee of \$10.00 per every 15 minute increment or any fraction thereof will be required and charged to your account for children remaining after program hours due to late pickup (beginning at 6:15 p.m.).
 - c) Other fees may apply as stipulated in individual program forms and brochures.
 - d) A.C.T. reserves the right to charge a 5% finance fee for payments made after the due date.
 - e) Credit card processing fee of 2.8% per transaction even if card is declined or reversed.
